

TERMS & CONDITIONS OF BEAUTY BLOWOUT PROGRAM

1. Select CITYWALK BEAUTY BLOWOUT Program (“BEAUTY BLOWOUT”) is a promotional scheme coordinated and managed by Select Infrastructure Pvt. Ltd. (“SIPL/SCW Management”) for the shoppers of Select CITYWALK for a fixed period of 04 days from 5th March to 8th March 2021 wherein a person will get gifts and other benefits, upon shopping from participant stores at Select CITYWALK.

2. In this Program, the Shopper will get gifts and other benefits, as per the scheme specified herein below, of purchase value, paid in cash / through card by him/ her in the participant stores at Select CITYWALK. The Shopper shall visit the Special Desk or any designated place at Select CITYWALK and show the original Invoice / bill of current date’s purchase to get the gifts / gift hampers and other benefits:

3. Apart from above, a lucky draw will be organized among the participants and SIPL will select 08 participants through a process as a lucky draw winner. The lucky draw winners will get Dyson Supersonic Hair Dryers.

4. The Shopper will submit his / her current dated original purchase invoice / bill at the Special Desk and upon fulfilment of form/information relating formalities, the Shopper will get the benefit, specified herein above. The gifts / gift hampers once handed over will not be cancelled or withdrawn or changed. Shopper hereby confirms that at the time of participation in the BEAUTY BLOWOUT, his / her age is above 18 years.

5. This program will not be clubbed or merged or carried forward or benefit of this program will not be adjusted with any other program. The gifts / gift hampers have no monetary value other than as stated on the same and under no circumstances can they be converted into cash. SIPL reserves the right to reject any bill / invoice of the Shopper if there is any suspicion concerning to the bill / invoice.

6. The purchase amount for this program will be calculated on the actual payment (through Cash / Credit/ Debit card/ Cheque) made by the customer at the participating store. Any payment / adjustment through Gift Cards / Voucher/s, Promotional Discounts, Redemption of Points, etc. in a purchase will not be considered for calculating the reward points on the purchase.

7. Upon redemption of purchases into gift / discount voucher/s, the terms and conditions of the respective voucher shall be applicable and in the event of loss, misplace, expiry and / or damage of the voucher, the new and / or duplicate voucher will not be issued by SIPL. It is advisable to the Shopper to check the validity and other conditions of the gift / discount hampers before taking the voucher/s. Issued or Expired voucher/s will not be replaced or exchanged by SIPL.

8. By participating in this Program, a Shopper consents and grants a right to SIPL to retain information provided by the Shopper, including details of purchases made and other personal details. Further, Shopper allows SIPL to use the information for research, marketing, analyse and any other purposes, update him / her about any upcoming event / promotion / other information relating to Select CITYWALK in future. Shopper has a right to withdraw this consent through serving a written communication to SIPL in future.

9. SIPL reserves the right to discontinue, cancel or terminate the BEAUTY BLOWOUT and / or merge with any other such nature of Program at any time without assigning any reason and without giving any prior notice. The Shopper’s right to avail the facilities under this BEAUTY BLOWOUT will cease on the date the BEAUTY BLOWOUT is discontinued / terminated/ merged with other Program.

10. Gift / Gift Hampers/s and other benefit dispersal are at the sole discretion of the SCW Management and valid upto stocks last.

11. SIPL reserves the right to add, modify, delete or otherwise change these terms and conditions or any rules, schemes related to the BEAUTY BLOWOUT at its sole discretion, with or without notice.

12. Computation of the purchase amount by SIPL shall be final, conclusive and binding on the Shopper and will not be liable to be disputed or questioned.

13. All disputes, if any, arising out of or in connection, with or as a result of this BEAUTY BLOWOUT Program, shall be amicably resolved by both parties and decision of the Operation Head of Select CITYWALK shall be final and binding. The BEAUTY BLOWOUT Program is subject to the jurisdiction of the competent courts / tribunals at New Delhi alone.
